



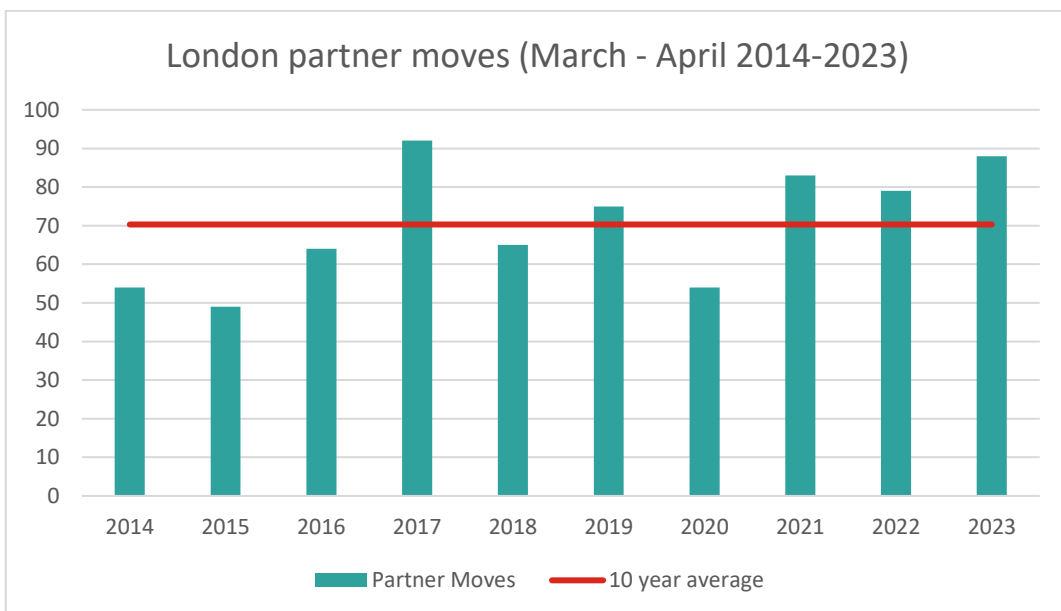
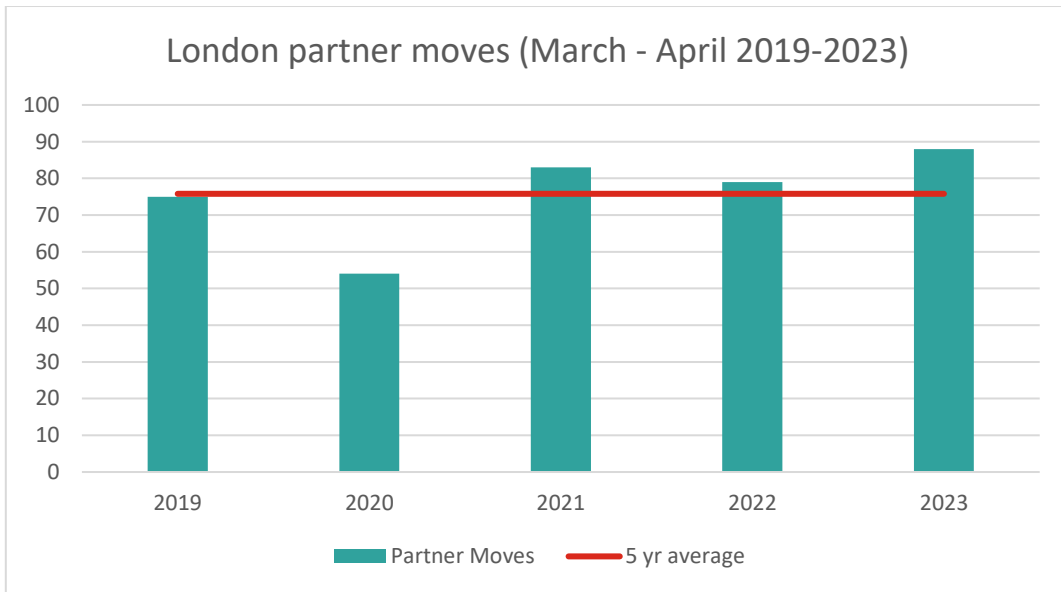

Welcome to the 74th edition of Law Firm Partner Moves in London, from the specialist partner team at Edwards Gibson, where we look back at announced partner-level recruitment activity in London over the past two months and give you a ‘who’s moved where’ update.

This bi-monthly round-up contains **88** partner moves – up 11% on the same period in 2022 (**79**), and 16% and 25% above the cumulative five-year and ten-year averages (**76** and **70** respectively).



The numbers in this edition are flattered by two factors in particular: **Milbank**'s acquisition of a half-dozen laterals from the London office of clandestine Scottish private equity boutique **Dickson Minto**; and by the enforced departure of a quintet of émigrés from the collapse of the legal services arm of funds boutique **MJ Hudson**. Whilst it was announced at the end of last year that the entire London office of Dickson Minto was to defect to Milbank Tweed (reported in our [72nd Edition](#)), in the event, finance lateral **Chris Barron** broke off to join rival New York firm Fried Frank in February 2023 (reported in our [73rd Edition](#)) and the final line up of arrivals was not confirmed until their appearance at Milbank in March.

In addition to the above, the following firms all hired 2 partners apiece: **Burges Salmon**, **Charles Russell**, **Fladgate**, **Gowling WLG**, **Shakespeare Martineau**, **Sidley, Squire Patton Boggs**, **Stephenson Harwood** and **Withers**.

Team hires

The two most sizable multi-partner team moves this edition were: **Milbank**'s acquisition of a 6 partner private equity and antitrust team from **Dickson Minto** (mentioned above) and Texas born **Haynes and Boone**'s poaching of a 3 partner private funds and venture capital team from (the now defunct) **MJ Hudson**. As per our [methodology](#) Edwards Gibson does not record as a "partner move" the transfer of individual partners to their new entity on a formal law firm merger. As such the hire of three contentious construction partners into **Howard Kennedy** - following its acquisition of construction boutique **Corbett & Co** in March 2023 - does not feature in our statistics.

In addition to the above, 8 firms: **BCLP**, **Harrison Clark Rickerbys**, **Herbert Smith Freehills**, **Ince**, **Latham & Watkins**, **Linklaters**, **Shearman & Sterling** and **Travers Smith** all lost 2 London-based partners to rival law firms.

Of interest to market watchers this round-up is an uber rare hire by white shoe firm **Sullivan & Cromwell** - which picks up a private equity lateral from **Allen & Overy**, as well as yet another hire by, traditionally conservative fellow New Yorker **Cleary Gottlieb** - which snaps up its fourth lateral in as many months (this time in the form of a finance partner from **Linklaters**). Despite losing two laterals **Linklaters** itself comes out net positive following its hire of three laterals from: **Shearman & Sterling**, **Travers Smith** and **Latham & Watkins** respectively. Indeed, in a quirky twist of recruitment fate **Linklaters** and **Latham & Watkins** trade partners with the magic circle outfit picking up a corporate infrastructure partner whilst at the same time losing an antitrust lateral to its LA headquartered rival.

The travails of Travers Smith continue ...

[In our last edition](#) we commented on the very high lateral attrition rate at **Travers Smith** – which had seen the 80 something partner firm lose no fewer than seven laterals to rivals in the preceding six months (against a 10-year historic attrition rate of one lateral p/a). Unfortunately, the travails of Travers Smith continue into this edition with the silver circle firm losing a further two partners in the form of a private funds specialist (to **Dechert**) and a private equity lateral (to **Linklaters**). As the quality of all the recently departed partners appears to be high (not to mentioned that at the time of writing there appears to be at least two further Travers Smith partners whose profiles have recently been taken down from the firm’s website), presumably the management at Snow Hill are considering contingencies – if so, we know an excellent legal recruiter they can speak to!

Ince ... and out

In April it was announced that the 100 something partner AIM listed legal business **Ince Group** was to go into administration. The troubled firm - a chimera comprising two legacy law firms: **Ince & Co** (a shipping, insurance, energy and aviation blue blood) and **Gordon Dadds** (a west end private client flavoured outfit) – has seen a steady stream of defections, including two this edition. Whilst rumours abound of potential suitors for the business, it is probable that the number of partner moves (enforced or otherwise) in our future editions will be bolstered by the flotsam and jetsam from the collapse of Ince Group. Similarly, by our reckoning, three further **MJ Hudson** partners may yet emerge at new homes following that (also listed) firm’s winding up of its legal business.

- **Also of note in this edition**

- **25%** (22) of all hires were female.
- **19%** (17) of all hires were non-partners moving into partnership.
- **5** firms hired from in-house this edition: **Ashurst** (from Goldman Sachs), **Bird & Bird** (from the Information Commissioner's Office), **Gately** (from Cromwell Property Group), **McGuireWoods** (from Co-Operative Bank) and **Norton Rose Fulbright** (from Morgan Stanley).

- **Addleshaw Goddard**

A trio of laterals for the international firm this round-up as it welcomes real estate partners **Sarah Atkinson** (from Greenberg Traurig) and **Catherine Williams** (from Shoosmiths) as well as infrastructure, planning and government affairs specialist, **Francis Tyrrell**, from Pinsent Masons. Atkinson advises on mixed use developments, private equity led real estate investments and income strip financings. Williams, who joins as co-head of the living sector, has a particular angle on residential and mixed-use developments. Tyrrell advises on infrastructure consenting and operation, environmental assessment, legislative drafting, and public law.

- **ASAFO & Co**

The Africa-focused outfit hires corporate lateral **Weyinmi Popo** from US firm Akin Gump as its new London managing partner. Popo specialises in private equity and M&A, as well as cross-border transactions with a focus on Africa.

- **Ashurst**

Returning to private practice is litigation and contentious regulatory lawyer **Philip Linton** from Goldman Sachs, where he was a managing director. Linton, who was head of the EMEA litigation and contentious regulatory team at Goldman Sachs, joins the disputes & investigations practice at the international firm.

- **Bird & Bird**

Data privacy lawyer **James Moss** arrives at the technology focused outfit from the Information Commissioner's Office, where he was Legal Director for Regulatory Enforcement. Moss advises on data breaches, defence of regulatory enforcement and other contentious data protection matters.

- **Boies Schiller Flexner**

The US disputes boutique boosts its international arbitration practice with lateral **Andrei Yakovlev**

from Chinese law firm King & Wood Mallesons. Yakovlev's practice includes investor-state and commercial arbitration, concentrating on energy, metals & mining, telecommunications and financial services disputes.

A brace of laterals this round-up for the London headquartered firm as it bags: private client disputes specialist **Ziva Robertson** from McDermott, Will & Emery; and construction lawyer **Francis Ho**, from Penningtons Manches Cooper. Robertson, who was head of private client at her former firm, is a solicitor-advocate who advises on contested estates and trust disputes. Ho advises on non-contentious construction and infrastructure projects.

- **Cleary Gottlieb Steen & Hamilton**

The New York firm snaps up its fourth lateral of 2023 in the form of finance lawyer **Ed Aldred** from Linklaters, where he co-headed the financial sponsor leverage finance practice. Aldred specialises in cross-border public and private leveraged acquisition and infrastructure financings.

- **Clyde & Co**

A vertical hire for the global firm which elevates corporate and restructuring lawyer **Rob Lowe** from Reed Smith, where he was counsel. Lowe has experience of corporate restructuring and general corporate M&A across a range of industry sectors including energy, natural resources, commodities and insurance and re-insurance.

- **Cripps**

Employment lateral **Sarah Glockler** joins the Kent headquartered firm from Memery Crystal. Glockler advises on a range of employment and HR matters with a particular focus on contentious work.

Henry, whose move is a team follow-on with antitrust lateral Douglas Lahnborg (reported in our [last edition](#) (73rd)), advises on EU and UK competition law and the UK national security regime. Scott advises on structured finance and securitisation, with a focus on CLOs.

Finance lawyer **Richard Sharples** emerges at the global verein after a year-long career break following his departure from Clifford Chance. Sharples specialises in leveraged finance, debt restructuring, private equity, acquisition finance, corporate and syndicated lending.

The big-four professional services firm strengthens its legal TMT practice with **Charlotte Walker-Osborn** from Eversheds Sutherland, where she was international head of the technology and artificial intelligence sectors.

Walker-Osborn has a broad range of TMT expertise with an angle on artificial intelligence.

- **Fieldfisher**

Life sciences regulatory lawyer **Robert Jappie** arrives at the European firm from the (now insolvent) listed outfit Ince. Jappie advises on food/agri-tech and healthcare - with a particular focus on cannabis regulation.

- **Fladgate**

Two lateral hires for the London firm this round-up as corporate lawyer **Tessa Trevelyan Thomas** joins from BDB Pitmans, while commercial technology specialist **Nathan Evans** arrives from the Cambridge office of Harrison Clark Rickerbys. Trevelyan Thomas' practice is focused on public and private M&A. Evans advises on procurement projects in the tech and outsourcing sphere.

- **Freeths**

The national firm welcomes dispute resolution lateral **Paul Kinninmont** from litigation boutique CANDEY. Kinninmont's practice is focused on international arbitration and commercial litigation across several sectors and jurisdictions.

- **Gateley**

Making the switch from in-house to the UK listed outfit is private funds specialist **James Gee** from Cromwell Property Group, where he was interim head of legal and compliance. Gee's experience includes advising fund managers, investors and teams on fund structures, fundraisings and related regulatory matters.

Corporate tax duo, **Matthew Poole** and **Paul Shaw** join the Anglo-Canadian outfit from Bryan Cave Leighton Paisner. Poole and Shaw both have a focus on commercial property taxation including acquisitions, disposals, development, real estate finance, property funds, joint ventures and cross-border investment structures.

- **Greenberg Traurig**

Finance lateral **Sierra Taylor** arrives at the global top 20 firm from fellow US outfit Paul Hastings. Taylor, who has directory rankings for both real estate finance and funds finance, advises investment banks as well as debt and investment funds.

- **Haynes and Boone**

The Texas-headquartered firm scoops up a three partner private funds and venture capital team from the, now defunct, funds boutique MJ Hudson. The trio comprising: **Karma Samdup**, (who joins as head of private funds and venture), **Andrew Pannell** and **Ronan McCann**, undertake a mix of asset management and corporate matters with a focus on the venture capital space.

- **Herbert Smith Freehills**

Arriving at the silver circle firm this edition is construction lateral **Matthew Bool** from Ashurst, where he was co-head of non-contentious construction. Bool acts for employers, developers, investors and lenders on construction documentation for large real estate developments.

- **Hogan Lovells**

Making the switch to the global firm is corporate energy lateral **Alastair Young** from Bracewell, where he co-chaired the oil and gas projects group. Young advises on M&A, cross-border joint ventures and the development of major energy projects.

- **Howard Kennedy**

Alongside the acquisition of construction boutique Corbett & Co - which sees Howard Kennedy elevate three contentious construction lawyers (all of whom were counsel or director at their previous firm) into its partnership - the London firm welcomes real estate lateral **Huseyin Huseyin**, from Harold Benjamin. Huseyin, who was head of development at his previous firm,

specialises in residential and mixed use development.

- **Hunters Law**

Corporate and commercial lateral **Piers Larbey** joins the Lincoln's Inn firm from Fletcher Day. Larbey advises on an eclectic range of corporate and commercial matters including M&A, re-organisations, joint ventures and investment agreements.

- **Irwin Mitchell**

After spending less than a year at west end firm Collyer Bristow, commercial litigation and arbitration lateral **David Vaughan**, arrives at the national firm. Vaughan has an eclectic disputes practice across a range of sectors.

- **Kingsley Napley**

The London firm welcomes three laterals this edition: insolvency and restructuring duo **Daniel Sejas** and **Nick Hughes** arrive from Harrison Clark Rickerbys, where Sejas was head of restructuring and insolvency; and disputes specialist **Melanie Hart** joins from (the now insolvent) law firm Ince. Sejas who will lead the firm's restructuring and insolvency practice, advises on both contentious and non-contentious restructuring and insolvency. Hughes focuses on knock about corporate and personal insolvency litigation. Making the switch from in-house is finance lawyer **Christian Lambie** from Morgan Stanley, where he was legal counsel. Lambie, formerly a partner at Allen & Overy, is a securitisation specialist with experience in commercial mortgage-backed securities, structured finance, distressed portfolio trading and workouts.

- **O'Melveny & Myers**

Following raids by rivals on its once mighty private funds team (which saw it lose most of its London partnership in 2019), the Los Angeles headquartered firm fights back with its first lateral hire since 2017 in the form of restructuring

and finance lateral **Greg Campbell** from Gibson Dunn & Crutcher. Campbell advises creditors, and investors on cross-border restructurings, financings and special-situations transactions.

- **Paul Hastings**

The US firm snaps up international arbitration specialist **Garreth Wong** from Shearman & Sterling. Wong, who joins his new firm as global co-chair of international arbitration, primarily advises on commercial and construction arbitrations but also has experience of investment treaty arbitrations, commercial litigation and global investigations.

- **Penningtons Manches Cooper**

Arriving at the London and south-east focused firm this round-up is corporate tax specialist **Oliver Gutman** from national firm Shakespeare Martineau. Gutman advises on the tax aspects of restructurings, debt finance, real estate and corporate transactions.

- **Pinsent Masons**

A trio of lateral hires for the national firm this round-up: international arbitration specialists **Sylvia Tonova** (from Jones Day) and **Graham Coop** (from Volterra Fietta) arrive alongside IT and cyber disputes specialist **Eleanor Ludlam** from DAC Beachcroft.
